Engineering Report

Joe Roenfeldt presented Charge Order 2 for the Fuel Farm Project. Due to new rulings by the FAA Central Regional Airport Planning Office, several items previously declared eligible for grant reimbursement were now explicitly ineligible, creating approximately \$115K additional expense to the project, which local funds would have to pay. A consensus was reached that the Commission should challenge these rulings since all the grants for this project were executed by all parties prior to the FAA State Airport Engineer's declaration that items that were once eligible in the executed grants were no longer eligible. The Chair will present the Commission's position to FAA supervisors at the Four States Conference in Kansas City in hopes of reversing the decision. In the meantime, to keep the construction project on schedule, it was recommended that the Chair notify the City Council of the need for a budget amendment that would allow using LOST Funds designated for the local match of runway 15-33 extension to pay for the \$115K expense reflected in the change order.

The Chair will schedule a special meeting for the Commission to approve Change Order 2 pending Council approval of the budget amendment.
