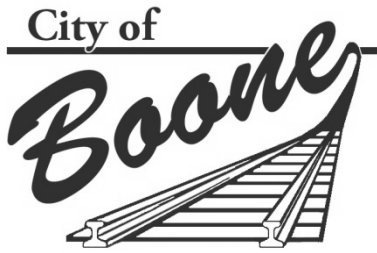

1. Call Meeting to Order.

2. Approve Minutes from the May 28, 2025, Public Safety Meeting.

Henson moved; Angstrom seconded to approve the minutes from the May 28, 2025, Public Safety meeting. Ayes: all those in attendance. Nays: none.

3. Request for an Easement to Access 1811 12th Street. – Michael Johnston.

Michael Johnston requested an easement to access 1811 12th Street in Boone, Iowa, with the intent of building a house on the lot. Andrews explained that while it is typical for a developer to improve the road and utilities, this situation involves a single lot, and the most straightforward solution would be to grant Johnston an easement to access his property. Johnston would be responsible for extending the utility connections from Champa Street to his property, including installing a stop box on his lot. Henson moved; and Angstrom seconded to direct staff to draft an easement allowing access to the property at 1811 12th Street. The easement is to include language stating that Johnston will be responsible for maintaining the easement, but it will terminate if the City later decides to develop the road. Ayes: all those in attendance. Nays: none.

4. Request to Change the Parking Regulations Adjacent to the Property at 735 10th Street, Boone, Iowa. – Barney Bornhoft.

Barney Bornhoft explained that they have remodeled a nine-unit apartment complex located at 735 10th Street and are requesting a change to the parking regulations to allow overnight parking on 10th Street for the apartment building. Wiebold noted that this area falls within the business district, where parking is currently prohibited from 2:00 a.m. to 5:00 a.m., however, he stated he is comfortable with removing the 700 block of 10th Street from the business district designation. Andrews recommended revising the parking regulations to allow overnight parking on both blocks along the north side of

10th Street, while only permitting parking on the east side of Boone Street. Henson moved; Angstrom seconded to direct staff to draft an ordinance reflecting these changes and to present it to the full council at the August 18, 2025 meeting for the first reading. Ayes: all those in attendance. Nays: none.

5. Other Business.

Andrews advised that he will be removing the blockades at the Little League Park now that the season has concluded.
